<u>Time Limits.</u> Public comments are welcomed during the Public Comment periods for all matters, whether listed on the agenda or not, and are limited to three minutes per person. Additionally, public comment of three minutes per person will be heard during individual action items on the agenda. Persons are invited to submit comments in writing on the agenda items and/or attend and make comment on that item at the Board meeting. Persons may not allocate unused time to other speakers.

Forum Restrictions and Orderly Conduct of Business. The Board conducts the business of the District and its citizens during its meetings. The presiding officer may order the removal of any person whose statement or other conduct disrupts the orderly, efficient or safe conduct of the meeting. Warnings against disruptive comments or behavior may or may not be given prior to removal. The viewpoint of a speaker will not be restricted, but reasonable restrictions may be imposed upon the time, place and manner of speech. Irrelevant and unduly repetitious statements and personal attacks which antagonize or incite others are examples of speech that may be reasonably limited.

Responses to Public Comments. The Board can deliberate or take action only if a matter has been listed on an agenda properly posted prior to the meeting. During the public comment period, speakers may address matters listed or not listed on the published agenda. The Open Meeting Law does not expressly prohibit responses to public comments by the Board. However, responses from Board members to unlisted public comment topics could become deliberation on a matter without notice to the public. On the advice of legal counsel and to ensure the public has notice of all matters the Board will consider, the Board members may choose not to respond to public comments, except to correct factual inaccuracies, ask for staff action or to ask that a matter be listed on a future agenda. The Board may do this either during the public comment item or during the following item: "*Commissioners'/Chief's Announcements, Requests for Information, Topics for Future Agendas and Statements Relating to Items Not on the Agenda".







Typical Fall Weather


- Typically mild and dry with chances for either wet or dry cold fronts during October and November.

- Season ending events typically average around October 15th, but can be as late as January.































Key Takeaways

SUMMARY

This item is discussion and possible approval of a side letter agreement between Truckee Meadows Fire Protection District and International Association of Firefighters Local 3895 to allow donations of annual or compensatory leave from employees to Captain Bill Winchester in excess of the 672 hour maximum negotiated in the collective bargaining agreement.

Strategic Objective supported by this item: Safe, Secure and Healthy Communities.

PREVIOUS ACTION

None

BACKGROUND

In September 2014, Mr. Bill Winchester, a Captain in the Association suffered a severe non-work related injury and has been unable to work since that time. As a result, Mr. Winchester exhausted his sick leave bank, received donations from other employees, and has exceeded, or will soon exceed, the 672 hours of donated leave allowed in Article 26.J of the agreement.

On April 21, 2015 the Board of Fire Commissioners approved a position in concept for Fire Officer in Charge of Strategic and Volunteer Services (FOIC). On August 24th the District offered him the FOIC position. Mr. Winchester is currently determining his ability to perform the essential functions of the job and states that he will need until approximately October 30, 2015 to complete and receive the results for the essential functions analysis. Staff understands that in order to maintain his PERS disability status during this period of time he must remain on sick leave with the District.

As of September 14, 2015 Mr. Winchester's sick leave bank has been exhausted. He will need approximately 304 hours donated to carry him through the month of October.

FISCAL IMPACT

As long as Captain Winchester is utilizing sick leave, the District is required to backfill his position with overtime. However, when one employee transfers hours to another employee, the hours are transferred at a converted rate which does not create a fiscal impact.

RECOMMENDATION

Staff recommends that the Board approve a side letter agreement between Truckee Meadows Fire Protection District and International Association of Firefighters Local 3895 to allow donations of annual or compensatory leave from employees to Captain Bill Winchester in excess of the 672 hour maximum negotiated in the collective bargaining agreement.

POSSIBLE MOTION

Should the Board agree with the staff's recommendation, a possible motion could be:

"I move to approve a side letter agreement between Truckee Meadows Fire Protection District and International Association of Firefighters Local 3895 to allow donations of annual or compensatory leave from employees to Captain Bill Winchester in excess of the 672 hour maximum negotiated in the collective bargaining agreement."

Dear President Satterfield,

This is a Side Letter Agreement to the 2014-2018 CBA between the District and the Association. The District and the Association hereby agree as follows:

- 1. The 2014-2018 CBA negotiated by the District and Association, at Article 26.J, allows employees to voluntarily transfer up to a maximum of 112 hours of accumulated vacation and compensatory leave during any calendar year to an employee who has no accumulated sick leave hours, but who is otherwise eligible to take paid sick leave. The CBA provides that donated vacation and sick leave hours are converted to money at the hourly rate of the donor and then converted to sick leave at the hourly rate of the recipient. The CBA further states the maximum amount of annual or compensatory leave that may be donated is 672 hours per calendar year.
- 2. In September 2014, Mr. Bill Winchester, a Captain in the Association suffered a severe non-work related injury and has been unable to work since that time. As a result, Mr. Winchester exhausted his sick leave bank, received donations from other employees, and has exceeded, or will soon exceed, the 672 hours of donated leave allowed in Article 26.J.
- 3. Mr. Winchester has applied and been approved for disability retirement with the Nevada PERS system, but has also desires to accept an offer of employment with the District in a different position for which he is currently determining whether he can perform the essential functions of the job. If he cannot perform the duties of the new position it is his stated intention to pursue the PERS disability retirement.
- 4. It is the understanding of the Association and District that, in order to maintain his PERS disability status during the period of time Mr. Winchester is determining his ability to perform the essential functions of the job that he must remain on sick leave with the District.
- 5. Mr. Winchester states he will need until approximately October 30, 2015 to complete and receive the results of the essential functions analysis.
- 6. The Association now requests the District make an exception to Article 26.J of the CBA to allow Bill Winchester to accept vacation and compensatory leave donated by employees in amounts in excess of the 672 hour limits to allow Mr. Winchester the time necessary to complete the essential functions analysis.
- 7. Subject to the conditions stated herein, and based on the unique facts and circumstances presented by Mr. Winchester's injury and the efforts of the Parties to assist Mr. Winchester in determining whether he can remain employed or will finalize his disability retirement, the District agrees to make an exception to the 672 hour limit described in Article 26.J of the CBA, and will agree to increase from 672 hours to 1022 hours the maximum amount of accumulated leave which may be transferred to Mr. Winchester pursuant to that Article.

- A. There are no other exceptions to the CBA besides that described in Paragraph 7, above.
- B. This extension is given based on the unique facts and circumstances presented by Mr. Winchester's situation as described herein.
- C. That because of the unique facts and circumstances presented by Mr. Winchester's situation, this agreement is intended to apply only to Mr. Winchester, and neither the circumstances underlying this Side Letter Agreement nor the Side Letter Agreement itself shall form the factual or legal basis for, or be used as precedent in, any future employment action, grievance or dispute brought by any employee, employee association, including Association, against the District, except to assert or defend against a claim of breach of this Side Letter Agreement.
- 9. Unless extended in a writing executed by both Parties, this Side Letter Agreement shall expire of its own accord and be of no force or effect on and after November 1, 2015, notwithstanding any other provisions of the CBA or any other agreement to the contrary. Upon termination of the Agreement, because Mr. Winchester will either be employed by the District, retired with PERS, or otherwise no longer in the employ of the District, he will not be allowed additional leave donations.
- 10. This Side Letter Agreement shall not be effective until signed by duly authorized representatives of the District and Association, both of whom represent by their signatures below that they are so authorized.
