TRUCKEE MEADOWS FIRE PROTECTION DISTRICT RESOLUTION TO AUGMENT AND AMEND THE FY 1999-2000 BUDGET

WHEREAS, the revenues of the General Fund, Capital Projects Fund and Health Benefits Fund were budgeted to be \$11,366,698, and \$530,000, respectively on July 1, 1999; and

WHEREAS, additional resources are available to these funds in which appropriations are required to be augmented as follows:

BE IT FURTHER RESOLVED, that the District Fire Chief shall forward the necessary documents to the Department of Taxation, State of Nevada.

DISCUSSION AND UPDATE - FIRE CONSOLIDATION

Marty Scheuerman, Acting Fire Chief, stated that both Labor Unions overwhelmingly approved the contracts that were offered. He further stated that Local 2487's contract will be brought back before the Board for ratification as well as a resolution to go forward with the consolidation on June 27, 2000.
