02-58F PROCLAMATION DECLARING OCTOBER AS FIRE PREVENTION MONTH IN WASHOE COUNTY

Chairman Sferrazza read the following Proclamation into the record and presented it to Chief Scheuerman:

PROCLAMATION

WHEREAS, There are over 2 million fires reported every year; and

WHEREAS, Fire is the third leading cause of death in the home; and

WHEREAS, Over 30 percent of the fires that kill children are started by children; and

WHEREAS, Annually an average of 100 firefighters are killed in the line of duty and over 87,000 are injured; and

WHEREAS, The Reno Fire Department, Community Risk Reduction Division, actively and aggressively involves the community in fire prevention by inspection, education and awareness; and

WHEREAS, The Reno Fire Department, Community Risk Reduction Division, is involved in the code writing and enforcement process, striving for a safer lifestyle for the residents of Reno and the Truckee Meadows and a safer environment for firefighters engaged in firefighting, rescue and medical emergencies; and

WHEREAS, The Reno Fire Department, Community Risk Reduction Division, in the tradition of the fire service as a whole, is a progressive, innovative and powerful force in making the Reno and Truckee Meadows area safer for all inhabitants.

I, the Chair of the Board of Fire Commissioners, for the Truckee Meadows Fire Protection District, proclaim the month of October to be Fire Prevention Month in the City of Reno and Washoe County.
