### 03-22F TENTATIVE AND FINAL BUDGETS – FISCAL YEAR 2003/04

**10:30 a.m.** This was the time set in a Notice of Public Hearing published in the *Reno Gazette-Journal* on May 9, 2003 to consider the Tentative Budget, as well as possible adoption of the Final Budget, for the Truckee Meadows Fire Protection District for Fiscal Year 2003/04. Proof was made that due and Legal Notice had been given.

Marty Scheuerman, Chief of Operations, noted the Fire Protection District is becoming financially strong and there is a 7.86 percent estimated increase in total revenues and a 2.06 percent increase in expenditures. He said the future liability for the Retirees' Health Insurance fund is over 50 percent fully funded. In response to Commissioner Galloway, Mary Walker, Walker & Associates, reviewed savings. She said the Fire Protection District is in its fourth year of the contract with the City of Reno and in that time, there has only been an increase of 8 percent and she feels the consolidation has been very successful.

Vice Chairman Shaw opened the public hearing by calling on anyone wishing to speak. There being no response, the public hearing was closed.

On motion by Commissioner Galloway, seconded by Commissioner Weber, which motion duly carried with Commissioner Sferrazza absent, Vice Chairman Shaw ordered that the Tentative and Final Budgets for Fiscal Year 2003/04 be approved.
