The Board members and Katy Singlaub, County Manager, commended the fire crews for their tremendous effort in handling the Robb Drive fire that occurred July 14, 2003.

Commissioner Galloway requested a report concerning what air resources are available for fighting fires in light of the air tankers being grounded.

In response to Commissioner Shaw, John Singlaub, Bureau of Land Management, stated there was one heavy air tanker from Chico, California, and two single-engine planes, each carrying 800 gallons, that were very effective on the fire of the previous night. He said there were also two planes out of California and the Nevada Division of Forestry had a helicopter on the fire.

PUBLIC COMMENTS

Sam Dehne, Reno citizen, stated the smaller planes are more maneuverable for fire fighting, but they cannot carry as much water.
