04-23F <u>ENGAGEMENT LETTER - KAFOURY ARMSTRONG & CO. –</u> AUDITING SERVICES

On motion by Commissioner Humke, seconded by Commissioner Galloway, which motion duly carried, it was ordered that the engagement letter between the District and Kafoury, Armstrong & Co., concerning the annual audit for the fiscal year ending June 30, 2004, be approved and Chairman Shaw be authorized to execute the same.

04-24F VOLUNTEER FIRE ASSISTANCE GRANT NEVADA DIVISION OF FORESTRY - PALOMINO VALLEY AUXILIARY FIRE COMPANY

Upon recommendation of Roy Slate, Division Chief, through Chuc Lowden, Fire Chief, on motion by Commissioner Humke, seconded by Commissioner Sferrazza, which motion duly carried, Chairman Shaw ordered that the Volunteer Fire Assistance Grant from the Nevada Division of Forestry for equipment for the Palomino Valley Auxiliary Fire Company in the amount of \$10,000 be accepted and that the Comptroller be directed to increase the District's capital budget by \$10,000. It was further ordered that expenditure of the grant plus \$5,822 in required matching funds be authorized for a new patrol truck to be assigned to Palomino Valley.

COMMISSIONERS'/CHIEFS' ANNOUNCEMENTS

Commissioner Galloway asked about the status of the new volunteer fire company facilities. Chief Neilson said the Auxiliary/Volunteer Report provided the status of the facility improvements.

Later in the meeting, Commissioner Galloway expressed his displeasure that he had requested specific information on the status of the new facilities for volunteer units and staff referred him to a report. After reading the report, Commissioner Galloway was very dissatisfied that staff has rejected the rebids received on the Silver Lake Volunteer Fire Department facilities without bringing it to the Board. He stated he had previously requested numbers on the overruns so the Board could consider the option of supplementing the project budget. Commissioner Galloway said staff has not followed the Board's direction. He further stated that, if the Board's acceptance of the Auxiliary/Volunteer Report in anyway provided Board approval of the rejection of these bids, he would request the item be reconsidered.

On motion by Commissioner Galloway, seconded by Commissioner Humke, which motion duly carried, Chairman Shaw ordered that acceptance of the Auxiliary/Volunteer Report, March 2004, (No. 04-22F) be reconsidered. Commissioner

Galloway also requested that the bid information on the Silver Lake Volunteer facilities and alternatives to rejecting the bids be brought back to the Board as soon as possible.
