#### **08-37F AGENDA ITEM 4**

Agenda Subject: "Authorize the Finance Director to Renew the Property and Liability Insurance Policy for the Truckee Meadows Fire Protection District with the Nevada Public Agency Insurance Pool, effective July 1, 2008, for an Annual Premium of \$135,002.27."

Commissioner Galloway requested more alternatives to be included in next year's staff report. Division Chief Marty Scheuerman indicated other alternatives were explored by Risk Management, but there was a very small risk pool to draw from. He said the District was in a pool with other public entities and there were a limited number of companies offering the insurance. Doreen Teasley, Senior Risk Management Analyst, introduced Gary Roberts, a broker from Wells Fargo Insurance. Mr. Roberts explained there were very few markets to provide the type of insurance coverage that was necessary. He stated the Sierra Fire Protection District and the Truckee Meadows Fire Protection District had been placed into a pool with approximately 100 other municipalities. He indicated there was one other market that had gone out of business three years ago and subsequently realigned with a different market. He assured Commissioner Galloway they would be considered for the next fiscal year.

On motion by Commissioner Humke, seconded by Commissioner Jung, which motion duly carried, it was ordered that Agenda Item 4 be authorized and approved.

#### 08-38F AGENDA ITEM 5

<u>Agenda Subject</u>: "Commissioners'/Manager's Announcements, Requests for Information, Topics for Future Agenda and Statements Relating to Items Not on the Agenda. (No discussion among Commissioners will take place on this item.)"

Chairman Larkin noted he received a letter from the Air National Guard in Washington D.C., which he provided to the County Manager, turning down the suggestion to have more air resources stationed in Northern Nevada. He requested a future agenda item to discuss getting some units retrofitted and redeployed in the State of Nevada. Division Chief Marty Scheuerman pointed out the recent fire activity to the west might create a different view on the issue by the end of the summer. He observed the North Carolina National Guard had just been deployed to California. Chairman Larkin pointed out the Nevada National Guard had been deployed in Wyoming.
