Incidents of Interest



Palomino Structure Fire

On August 30, TMFR Crews battled a residential structure fire of a two-story home on Anniversary Road off of Winnemucca Ranch Road in Palomino Valley. The fire resulted in a total loss with no injuries to occupants or firefighters.



Ted Court Sun Valley Fire

on September 7, TMFR Crews suppressed a structure fire involving a vehicle, shed, and mobile home. The fire was next to a daycare full of children that was evacuated but later not impacted by the incident.

No injuries to occupants or firefighters, and the cause is under investigation.



Caldor Fire

While the Caldor Fire impacted many areas and communities south of South Lake Tahoe, TMFR supported the incident with a strike team, dozer, and other resources included firefighters who were on the fire for two weeks in September.

Engine Donation

TMFR donated a Type I Fire Engine to Indian Valley Fire & Rescue (California). The department provides oversight for the fire stations in Greenville, Taylorsville, North Am, and Genesee, all of which have been impacted by the devastating Dixie Fire.

The engine is fully stocked with hoses, extrication tools, power fans, ladder, generator, and other equipment, along with EMS supplies.



Brady Fire

TMFR Crews established a portable tank for a water supply for an air attack operation on the Brady Fire north of Cold Springs.

The incident area was steep, rugged, and difficult to access. Aircraft from nearby California fires were diverted to support suppression. The 15-acre fire did not impact any structures.



Spanish Springs Compost Fire


Spontaneous combustion is the cause of the Donovan compost pile fire that filled the air in Spanish Springs of smoke for three days in September until it was extinguished.

TMFR crews provided initial attack and monitored the suppression of the fire by Donovan personnel to ensure it was not a threat to the community.
















Call Volume by Battalion
